Functions and Duties:

Under the responsibility of the Head of Unit B.2, Ship Safety, the successful candidate will be part of a team and assist in the following duties:

- Overall monitoring of the implementation of EU maritime safety legislation related to the control of ships (Directive 2009/16/EC, on port state control) including analysis of statistical data and compiling of reports;
- Preparation of inspection visits to Member States. Visits are normally carried out by teams of three or four, guided by a lead assessor;
- Participation in technical working groups of the Paris Memorandum of Understanding on port state control;
- Drafting regulatory proposals related to implementation of control by the port state linked to various Regulations and Directives related to maritime safety and protection of the marine environment;
- Further development and implementation of the training methodology for port state control officers training including the support of the digital tools RuleCheck, the Learning Management System and THETIS.

Main skills and qualifications:

- University degree or equivalent qualification or professional experience;
- At least 4 years of professional experience acquired after the award of the required qualification. When no university degree or equivalent qualification has been acquired, 8 years of experience is required of which 4 must be relevant to the post;
- Good knowledge of EU maritime safety legislation, in particular in the field of port State control, ship safety and protection of the marine environment;
- Good knowledge of the principal IMO and ILO maritime Conventions;
- Overall knowledge of the roles and functions of stakeholders in the Maritime Community (i.e. IMO, ILO, EU and EMSA, ship building and repair yards, ship owners and industry organisations, recognised organisations, IACS, flag, port and coastal states, offshore registries etc);
- Knowledge of the survey and inspection regimes associated with seagoing vessels engaged in international trade;
- Very good level of written and spoken English with the ability to draft clear and concise texts;
- Ability to make presentations to groups;
- Knowledge of development and implementation of IT systems would be an advantage.
