Procurement procedure No. EMSA/NEG/20/2017 for Purchase of wall partitions and related services

<p>Subject & requirements</p>	<p>The goal of this procurement is to establish a Framework Contract for the supply, assembly and disassembly of fixed and movable wall partitions and doors in specific locations in EMSA's building. The required services are as follows:</p> <p>Fixed partitions and doors:</p> <ol style="list-style-type: none"> 1. Supply of opaque steel panels, maximum 82mm thick, with mineral wool inside as acoustic insulation. 2. Supply of glass panels, maximum 82mm thick, with micro blinds on the inside. 3. Supply of interior doors, including frames, accessories, hinges and locks. 4. Assembly of steel panels similar to the ones described in point 1 5. Assembly of glass panels similar to the ones described in point 2 6. Assembly of doors similar to the ones described in point 3 7. Disassembly of steel panels similar to the ones described in point 1 8. Disassembly of glass panels similar to the ones described in point 2 9. Disassembly of doors similar to the ones described in point 3 <p>Movable and retractable walls:</p> <ol style="list-style-type: none"> 10. Supply of movable and retractable interior walls, maximum 110mm thick, with acoustic absorption of minimum 40 dB, including all its elements and necessary materials, such as standard and telescopic panels, beam structural reinforcement, peripheral finishing in the intervention areas and acoustic protection between false ceiling and upper slab. 11. Assembly of walls as described in point 10 12. Disassembly of walls as described in point 10 <p>Points 4 to 9, 11 and 12 shall also include finishing touches in the perimeter of the intervened rooms (pavement, walls and ceilings) and the storing of the removed materials in to EMSA's storage room.</p> <p>At the moment EMSA uses <i>Maars Metaline</i> fixed partitions, and requires products similar to the existing ones for this contract. Movable walls shall also be similar to the existing materials.</p> <p>Bidders are required to offer, by filling in Annex 1 to this Invitation:</p> <ol style="list-style-type: none"> i. prices for m2 for each of the points listed above ii. response times following a request from EMSA (i.e., how many days will it take to deliver the goods and/or services): <ol style="list-style-type: none"> a. response times for delivery of materials in 1), 2), 3) and 10) b. response times for services in 4), 5), 6), 7), 8), 9), 11) and 12). For these services, the maximum admissible time will be two weeks.
