The Agency also contributes to the overall efficiency of maritime traffic and maritime transport and supports European cooperation on coastguard functions.

#### **Functions and Duties:**

Under the responsibility of the Head of Unit C.1. 'Pollution Response Services', the successful candidate will assist in the following duties:

- Preparing plans, schedules and check-lists for drills and exercises of EMSA contracted vessels and/or stand-alone Equipment Assistance Service (EAS) systems;
- Monitoring drills and exercises of the contracted vessels and/or EAS systems regarding various aspects of readiness to the pollution response;
- Preparing reports and assessments of the results of drills and exercises;
- Contributing to the further development of the pollution response services with improvement proposals and projects;
- Assisting in the development of the Agency's capability to provide technical assistance in the field of accidental or deliberate pollution by ships to the European Commission and Member States;
- Participating in the operational marine pollution response emergency procedures related to the EMSA network of stand-by oil recovery vessels and/or EAS;
- Providing expertise and supporting the Agency's marine pollution response activities.

#### Main skills and qualifications:

- A university degree or equivalent qualification or professional experience;
- At least 3 years of professional experience acquired after the award of the required qualification.
   When no university degree or equivalent qualification has been acquired, 7 years of experience is required of which 3 must be in the field of at sea pollution response;
- Proven experience working with pollution response issues;
- Demonstrated work experience with pollution response equipment;
- Proven experience in maritime safety, either gained at sea as a Navy or Merchant Marine officer or through the work for a maritime administration will be considered advantageous;
- Experience in contingency planning will be considered advantageous;
- Experience in managing external contractors will be considered advantageous;
- Experience in pollution response operations will be considered advantageous;
- Good communication in both written and spoken English.
