"Coronavirus (COVID-19) – Guidance relating to the Seafarers' Employment Subject: Agreements".

1. As known, the World Health Organization (WHO) has determined that the outbreak of Coronavirus Disease (COVID-19) is a pandemic on 11 March 2020. It is evident that stringent border control measures to reduce the spread of COVID-19 implemented by states across the world has resulted in shipowners/operators having extreme difficulty in arranging crew changes and repatriating seafarers when their employment agreements (SEAs) expire. Therefore, this Administration allows for the extension of SEAs¹ provided that such an extension is under the seafarer's consent and that all the relative arrangements by the shipowner/operator for repatriation will be undertaken as appropriate at the next available port as soon as conditions allow.

2. In such cases, the extension of the contractual period should be reflected on the corresponding SEA of the affected seafarers, when a new SEA may not be timely arranged, the duration of which (contractual period) shall be mutually agreed. Furthermore, an entry shall be made in the ship's official logbook pertaining to the circumstances and the seafarers whose SEAs have been extended.

The present document² is recommended to be kept onboard for verification reasons 3. from the competent authorities, as appropriate. In case that a Greek flagged vessel is under port state control being imposed with restrictions for pertinent issues, the Seafarers' Labour Directorate (dner.b@hcq.gr) should be relatively informed. Further to the present document, the IMO Circular Letter No.4204/Add.5/17 March 2020 should also be available onboard.

4. Shipowners' and Seafarers' organisations are requested to advise their members accordingly.

Notwithstanding the present conditions of extreme necessity, it is in general perceived that PSCOs' actions, when a SEA is extended beyond 11 months, should not, in principle, be to the detriment of the concerned seafarer when there is evidence that the seafarer is aware of his/her right for annual leave and has been provided with the means necessary to exercise it.
