20TH EMSA BOARD MEETING IN ATHENS

The 20th meeting of the Administrative Board took place in Athens on 6th March, back-toback with the Mare Forum Conference entitled "Maritime Transportation of Energy from Russia and Central Asia - Challenges and Opportunities," and co-hosted by the Hellenic Ministry for Mercantile Marine, the Aegean and Island policy. The main topics for discussion by the Board were: the preliminary work programme and budget 2009: SafeSeaNet; the New Information System for Port State Control and; the European Union Long Range Identification and Tracking (LRIT) Data Centre. These will continue to represent the main challenges for EMSA in 2009. The Board also had the opportunity to discuss the final outcome of the independent external evaluation of the Agency.

LRIT EXPERT GROUP FIRST MEETING

The first LRIT Expert Group meeting took place at EMSA on the 25-26th February, bringing together 24 Member States, the European Commission and EMSA. The main objectives of the meeting were: to present the EU LRIT Data Centre Implementation Plan to the Expert Group; to discuss the main steps in the project; to consult the group on key issues relating to the development of the various parts of the project and; to ensure that Member States' suggestions for technical improvements were taken into account. On 8th March, a new procurement procedure for the EMSA Stand-by Oil Spill Recovery Vessels Service (SOSRVS) covering the Black Sea and the North Sea areas was launched. The deadline for the submission of applications for the first phase of the procedure is 29th April 2008. The aim is to strengthen the vessel network by filling some of the remaining gaps. This will be done by setting in place three year renewable contracts with commercial ship-owners and/or operators and/or spill response organisations/manufacturers. It will be organised by the International Hydrographic Organization and will be attended by delegates from many different hydrographic institutes around the world. The event will provide delegates with the opportunity to better understand the activities of EMSA and the International Hydrographic Organization, and it will underline the importance of "Capacity building as a vital tool to assist the International Hydrographic Organization in achieving its mission and objectives." In this context, a Memorandum of Understanding will be signed between the IHO and EMSA, with the aim of strengthening cooperation between complementary public institutions in order to achieve the common goal of improving the safety of maritime traffic.
