# SAFESEANET DEAL SIGNED, FOR EU-WIDE TRAFFIC IMAGE VIA AIS

On 18 February, an agreement on SafeSeaNet, the Agency's core vessel traffic monitoring system, was signed by EMSA's Executive Director Willem de Ruiter and Vice Admiral Pollastrini, Commandant of the Italian Coastguard. The agreement secures the future of the AIS (Automatic

Identification System) information, which is supplied to Safe-SeaNet from over 700 shore -based stations across the EU. The new deal paves the way for SafeSeaNet users to obtain an EU-wide picture of coastal shipping movements (plus Norway and Iceland), together with a more user-friendly entry point into SafeSeaNet using a GIS mapping interface. Preparations during February included operator training for Member States. A notable development is that the new agreement for a data hub for the Mediterranean region — 'MARES' — recognises the potential for regional centres for EMSA, as foreseen in EMSA's founding Regulation.

Mr Tallec spoke to EMSA about the EU-funded, French-led BLUE-MASSMED Project for Mediterranean and Atlantic maritime surveillance. The visit also provided an opportunity to meet the Agency's French staff.

# GALILEO, GALILEO MAGNIFICO!


Newsletter readers are invited to visit EMSA's booth at the Galileo Application Days event at the European Commission in Brus-

## SATELLITE IMAGES DELIVERED TO TRACK GENOA OILSPILL

During the the last week of February, EMSA's CleanSeaNet service was called upon to help in the response to marine pollution following a collision on 19 February between the cellular container ship CMA CGM Strauss and



the tractor tug *Genua* in bad weather around 1.5 km off the Voltri terminal entrance at the port of Genoa, north-western Italy CleanSeaNet supplied satellite images of the sea area between Toulon and Genoa following a request by the French authorities.
