2015 FIRST QUARTER ACTIVITIES – EU MEMBER STATES, ICELAND AND NORWAY

The activities organised between January and March 2015 included three training courses and two seminars, all held in Lisbon.

37th PSC Seminar 23-26 March

The **36th and 37th PSC EMSA Paris MoU seminars** took place between 26-30 January and 23-26 March respectively. The first one was attended by 35 participants coming from EU Member States, and Norway and six representatives of other parties to the Paris MoU on PSC. The second seminar held in March brought together 35 participants from EU Member States , and Norway, and six representatives of other parties to the Paris MoU on PSC. A number of practical exercises on the application of harmonised procedures within the Paris MoU area took place. The seminar was an opportunity for the participants to interact and share findings.



36th PSC Seminar, 26–30 January

The **course on the enforcement provisions of the Sulphur Directive** provided a comprehensive overview of the directive, particularly focusing on the need for a stronger monitoring and enforcement regime in order to ensure proper implementation. This course was addressed to officials from the EU Maritime Administrations and any other Competent Authorities within the Member States with responsibilities on the enforcement of Directive 2012/33/EU. The course provided an overview of the requirements prescribed in the directive as well as guidance when conducting sulphur inspections and reporting in THETIS-S. The course was attended by 33 participants from 22 Member States, Norway and Iceland.

During this quarter experts of an external contractor delivered **two courses on ISM Code and Auditing Techniques**

on 10–13 February and 3–6 March. Each of them designed for a group of 15. The courses were open to participants from Member States, Norway and Iceland where 30 participants in total from 23 countries took part. Focusing on the practical issues related to the implementation of the ISM Code, the course included a number of practical exercises based on real situations, which was greatly valued and acknowledged by the majority of the participants.
