1. Background and introduction

The Consultative Technical Group for Marine Pollution Preparedness and Response (CTG MPPR) was established in continuation of the Management Committee for Marine Pollution (MCMP) following expiration of the Community framework for cooperation in the field of accidental or deliberate marine pollution. Against this background, the CTG MPPR acts as a forum for the exchange of good practices between the EU Member States. The promotion of cooperation and sharing of best practices between Member States in order to provide for cost recovery of damage in accordance with the polluter-pays principle is enshrined as part of the CTG MPPR's objectives.

Several Member States initiated discussions on the creation of a working group on claims management within the context of the Bonn Agreement and MCMP. In 2007, National delegates who attended an EU States Claims Management workshop organised by the UK Maritime and Coastguard Agency with funding from the European Commission, recommended that pollution response costs recovery should become a standing item on the agenda of the CTG MPPR.

The initial objectives of this working group as set by the States delegates at the 2007 EU States Claims Management workshop are:

- > To share claims management experiences among EU Member States;
- To standardise and recommend procedures and tariff schemes;
- To improve transnational co-ordination and evaluation of claims;
- > To reinforce EU Member States' position when settling claims;
- To identify a way forward and how further progress can be achieved by the CMWG;
- To be a discussion forum, review progress, etc.

The EU States Claims Management Working Group (CMWG) is currently composed of the following States:

Belgium, France, Germany, Norway, Spain, The Netherlands and the United Kingdom.

The members of the group have drafted the EU States Claims management Guidelines, a compilation of practical guidance and best practices for national claim handlers. The Guidelines are up-dated at regular intervals and endorsed by the CTG MPPR members.

In parallel four EU States Claims management workshops have been organised since the work of the CMWG has been transferred to the CTG MPPR.

This fourth workshop gathered 23 delegates from 17 States.

2. Objectives and Programme

The workshop was aimed more particularly at:

- Reviewing the updates to the "EU States Claims Management Guidelines";
- Pooling of experiences through sharing of States' best practices and presentations of cases.

The workshop agenda is attached as annex 1. The workshop lasted for one day. The morning was dedicated to the review by the delegates of the updates of the Guidelines as presented by the members of the working group acting as workshop facilitators. The updates introduced cover the following items:

- Methodology for establishing staff costs;
- Defining & level of administrative costs;
- Convention on Arrest;



- Freezing order;
- > Forum shopping.

Updates introduced were welcomed by the workshop participants with particular interest on the different national legislations and proceedings for arresting a ship.

The rest of the workshop was dedicated to presentations of the costs recovery process following recent maritime incidents.

3. Conclusions and recommendations

The working group will finalise the updates to the Guidelines in the light of the discussions held at the workshop.

The updated Guidelines will be presented to the CTG MPPR members before being published on the EMSA website.

Participants acknowledged the valuable contributions and deliverables of the members of the working group so far and confirmed the importance to continue the work in this respect. Several countries confirmed having used the Guidelines as a reference for drafting their own manuals. One country had the Guidelines referred to as best practices in the field during a court case.

Several delegates also expressed their appreciation of having the opportunity to meet with other civil servants in this matter. Such networking has led to fruitful co-operation during actual maritime claim settlement. In this regard, the participants agreed that similar workshop should be organised in the future. Regarding the format of future workshop of that kind, several delegates suggested inviting industry stakeholders such as P&I Clubs.


