- **HLSG 2 meeting (20 June)**
  - **new SSN Ecosystem Graphical interface Transition to Operations plan**
  - **agreed on testing the simplification of access rights via a dedicated pilot project**
  - **pilot project outcome: EMSA will analyse the operation and functioning of such simplification of access rights as compared to the current access rights policy and report back to next HLSG**
- **Considering the likely impact on the current access rights policy as defined in the IFCD, an ad hoc meeting of the IFCD revision Working Group was organised**

- **Analyse the impact of the proposal on simplification of access rights the in the current IFCD access rights policy**
- **Analyse the feedback provided by the pilot project participants**
- **Propose a new draft Chapter 3 and any consequential amendments to be validated by the SSN/LRIT group and endorsed by the HLSG**

## Very positive feedback from several pilot project participants (HR, IT, FI)

- around 90 users created for 5 MSs.

## Review entirely Chapter 3 on access rights:

- **Wording** in the document:
  - to clarify the implementation of access rights as defined in the matrix
- **Matrix for data provider**
  - LRIT added + MRS (restriction removed )
- **Matrix for data access:**
  - SSN Notification available to all
  - AIS available to all (removed restriction for ports)
  - Definition of « SSN Details » which are ruled by SSN access rights
  - Removed **port restriction** except for Hazmat, Waste, Security details
  - LRIT added with conditions
  - Removed restriction for AIS enriched distribution
