1. Introduction

1.1 Background

The 1st CISE Stakeholder Group (CSG) meeting took place at EMSA on 15th of May 2019. The meeting was convened by the CSG Chairman Mr Leendert Bal, EMSA.

2. Meeting session

2.1 Welcome and Opening

Leendert Bal, Head of Department C - Operations, welcomed all Member States (MS) and Agencies to this first meeting of the CISE Stakeholder Group.

Since the signature of the Grant Agreement on 16 April 2019 between EMSA and DG MARE, EMSA has been preparing the basis on which it can take the project forward. The 1st CISE Stakeholder Group meeting is indeed the opportunity to present what EMSA, JRC and DGMARE have organized to support the transitional phase and to share the status and plan of the CSG members for the transitional phase.

On this matter, Mr Bal spoke of excellent cooperation with both the JRC and DG MARE. He also recognised and appreciated the work that has already being done by the EUCISE2020 project.

The agenda was presented and adopted with some slight changes (see Annex 5.2)

Christos Economou, Head of Unit at DG MARE, acknowledged the extensive efforts that went into building the bridge between EUCISE2020 and the transitional phase, ensuring that no time would be lost.

In looking at the current state of play, Mr Economou said it was also important to look to the past. The whole idea of CISE started ten years ago. The project underlined the value of information sharing from maritime surveillance, showing that it was relevant to many. The objective is now to take it forward in a solid framework making it operational by 2021.

EUCISE2020 ended with a conference in March 2019 which was attended by many of those present at the 1st CSG. Since then, the IPR discussion has been advancing. A transfer agreement is in the pipeline and is expected to be ready soon to form the basis of the transitional phase.

To achieve the operational stage of a sustainable CISE Mr Economou mentioned the draft proposal for the Regulation for the maritime and fisheries fund (EMFF) post 2020. This proposal made by the Commission is now in negotiation with the Member States

2.3 Technical and operational support

Gianluca Luraschi, EMSA Project Officer, presented the support processes for technical and operational activities. The aims of these processes are to guarantee continuity of the CISE network during the CISE Transitional Phase, and they should help to support the CSG members.

Questions & Answers

DE	Germany noted the interest in the set-up of new nodes and wanted to find out more about where the interest came from.
	It was explained that more information on the interest raised for the installation of new nodes would be given in the short format presentations scheduled for the afternoon session.
FR	France mentioned that until now there was very much a project team approach and was pleased to note the involvement at national level. It also welcomed the identification of a working group to be involved at a technical level. France was happy with the proposal and acknowledged that much work still needed to be done at national level.
GR	Greece expressed a need for a more detailed assessment to look into both project and software management as well as to examine the timeline for the various procedures.
BE	Belgium asked whether or not the working group was only for those parties already with a node installed and expressed a wish to see it open to all so that the momentum in CISE development could be kept going more easily.
	It was explained that the stakeholder group could decide on the composition of the working group.
NL	The Netherlands proposed to change the name of the Architecture working group to avoid any confusion in the term "Architecture". The SG Member considered relevant to establish the baseline from EUCISE2020 to understand better the progress during the CISE Transitional Phase.
	The SG members agreed to change the name of the group to 'Configuration Board'. To establish the baseline, Commission is still negotiating the transfer of the IPR of the results of the EUCISE2020 project.

2.4 Transitional phase activities overview

Gianluca Luraschi, EMSA Project Officer, introduced how EMSA and JRC are going to address the activities defined in the MSEG Activities paper, and a plan to address them was proposed.

DE	Germany expressed confidence in the planning of the transitional phase as well as willingness that the work should begin quickly given that the entire framework would need to be looked into in depth by the Member States.					
	Mr Bal said that he understood the concern but cautioned that priorities have to be set, a number of activities have to be started, first the foundational phase has to be in place. It would not, he said, be realistic to start all activities immediately.					
EL	Greece expressed concern over the level of involvement expected from each Member State.					
	Mr Bal explained that the activities certainly had to be looked at, as well as how to use the node and any operational needs.					
	Bartel Meersman, from the JRC, explained that while there will be a lot of work to do on EMSA and the JRC side, Member States also need to do their homework to determine which information and datasets to share.					
DE	Germany also expressed eagerness to have a best practice workshop held sooner rather than later, to keep momentum and interest in the project high.					
	While Mr Bal appreciated the enthusiasm, a specific action will be taken to see if this request can be accommodated earlier.					
NL	The Netherlands, speaking as a newcomer, explained that they were happy to see EMSA get involved in the transitional phase. They were also keen to see progress, step by step, so that Member States could get their own management in order first.					
	Mr Economou emphasised that CISE stakeholders have a key role to play in relaying back messages to their national administrations. Particularly in explaining the many developments to CISE and that the club is expanding beyond a set of specific members and authorities.					
BE	Belgium expressed interest to know more about the activities being taken forward as soon as possible.

2.5 Legal services – Administrative Framework

Georg Troost, EMSA Legal Officer, presented the approach for establishing the agreements to exchange data between CISE stakeholders.

Questions & Answers

DE	Germany expressed its full support for this approach and said that it considered the group would be very lucky if it were to have this agreement in place by the end of the transitional phase given the complexities involved.
FR	France reminded those present of the philosophy behind CISE for a voluntary exchange of information, consolidating information that in some cases the users didn't even know existed. France mentioned that it should be open to new data providers and that it considers it important to have a legal framework in place.

Mr Bal explained that an initial document could be put together that the stakeholders could use as an initial basis for discussion. Mr Economou underlined that this is a very important part of the work that gives assurance to all equally on what can be shared and with whom.

This WG comprises experts appointed by CSG to be consulted in case there is request of changes in the common and core software. The configuration board will operate as correspondence group. The CSG members that do not have the node implemented can appoint an expert with the role of observer.	
D1/2 – "Cooperation Agreement WG"	To set-up the "Cooperation Agreement WG" working group. This WG comprises experts appointed by CSG to be consulted in order to establish the cooperation agreements for sharing information between CISE nodes. The working group will operate as correspondence group after an initial workshop to kick off the activity.	
D1/3 – WBS and Plan	The CSG agreed about the WBS and plan proposed to carry out the activities defined in the MSEG Activities Paper. The WBS and plan will be reviewed regularly in the CSG meetings.	 The possibility to anticipate the best practice workshop should be assessed. During the 2nd CSG meeting the "responsibility to share" activity should be discussed and possibly planned.
D1/4 – Single point of contact	cise-support@emsa.europa.eu is the single point of contact for the CSG members to request any technical and operational support. cise@emsa.europa.eu is the single point of contact for administrative requests/questions.	
D1/5 – management procedure	To cover the Technical and Operational needs the following procedures proposed by EMSA and JRC will be established: incident, problem, configuration, deployment and new installation request.
