


**Invitation to tender

Subject & requirements	<p>The European Maritime Safety Agency (EMSA) is launching an invitation to tender regarding the painting of walls and the polishing of the floor stone tiles in the terrace of the Cafeteria in its main building. The requirements are as follows.</p> <p style="text-align: center;">Painting area: 59,00m²</p> <p>Paint to be used (<u>technical sheets for the proposed products must be delivered with the bid</u>):</p> <ul style="list-style-type: none">• Density: 1,603 0,007(a 23°C)• Viscosity: 100 -110 KU (a 23°C)• Solids by Volume: 43,7 ±1,0 %• Flash Point: flameproof• Respecting EU limit for this product: (subcat. A/a): 30 g/l.• The colours to be used must match the ones presently used <p>In keeping with the above indicators, materials are accepted with variations in the parameters up to 10% up or down.</p> <p>Works shall include: the protection of the areas to intervene, removal of damaged and loose materials, opening and covering the existing cracks in the surfaces to intervene, cleaning the surfaces to intervene, preparing base for paint application, applying water-based matt paint in 2 coats, cleaning the area of intervention and removal of surplus materials.</p> <p style="text-align: center;">Stone polishing area: 248,00m²</p> <p>Works shall include: the protection of the areas to intervene, the polishing of the stone tiles in all the terrace area, the cleaning the area of intervention and removal of surplus materials. Given the structure of the floor tiling, each stone needs to be removed, polished and repositioned individually by hand.</p> <p>The contractor shall also ensure that tasks are carried out without detriment to the general functioning of EMSA services and shall be responsible for any damage caused to the buildings and external areas. Tasks may have to be carried out on weekends or outside the Agency's working hours.</p> <p>The price offer must be all inclusive (include the costs of the all works, materials and transport).</p>
