


Invitation to tender

<p>Subject & requirements</p>	<p>The European Maritime Safety Agency (EMSA) is launching an invitation to tender for a dinner service in a restaurant in the Lisbon area. The objective of this tender is to conclude a purchase order for the provision of a dinner for an estimated number of 60 persons.</p> <p>The dinner, addressed to the EMSA Administrative Board Members, will be held on November 13th, 2014 between 19:15 and 23:30.</p> <p>The contractor shall provide for each person:</p> <ul style="list-style-type: none"> • 1 Welcome drink • 1 Starter (minimum 3 options to choose from Fish/Meat/Vegetarian) • 1 Main Course (minimum 3 options to choose from Fish/Meat/Vegetarian) • 1 Desert (minimum 3 options to choose from) <p>In addition, mineral water, red/white wine and coffee shall be included.</p> <p>Description of service:</p> <p>Guests will be arriving at the venue as of 19:15 to start with the welcome drink and the dinner is expected to kick-off at 20:00 and to end by 23:30.</p> <p>The final number of attendance, table setup and the menu dishes will be confirmed prior to the event.</p> <p>A restaurant in a nice location with a view, pleasant surroundings and easy parking access would be preferred.</p>
