## **REVISED FOUNDING REGULATION OUT SOON**

The European Parliament has backed a report on the revision of EMSA's founding regulation as prepared by rapporteur Knut Fleckenstein. The vote held on 11 December saw 582 ballots in favour of the proposed amendments, 63 against and 33 abstentions. This means the new text has been adopted by the EU Institutions and needs now only to be formally signed. This is expected in January and publication of the revised text to take place shortly thereafter.

# ALL EYES ON LNG AS SHIPPING FUEL OF THE **FUTURE**

The third expert group meeting on LNG as a shipping fuel was held by DG MOVE and EMSA on 4 December. The expert group was set up in the context of the 2011

fuel in the EU, this third meeting focused on the possibility of an EU framework for LNG bunkering. Member State representatives and some international partners were invited to this meeting, in addition to the various shipowner, port and gas industry participants. The participants commented on the preliminary results of EMSA's commissioned study on 'standards and rules for bunkering gas fuelled ships' which will all contribute towards a possible future regulatory framework on EU LNG bunkering.

# NEW TASKS FOR EMSA IN THE MEDITERRANEAN

EMSA has officially become the implementing body of the Commission's technical assistance project for the Mediterranean Sea in the area of maritime safety, security and pollution prevention. The beneficiary countries of the SAFEMED 3 project are: Algeria, Egypt, Israel, Jordan, Lebanon, Libya, Morocco, Palestinian Authority, Syria and Tunisia. This project will run between mid-2013



and mid-2016. The SAFEMED 3 project, which builds on the results of the previous two projects, has the overall objective of improving the protection of the Mediterranean Sea marine
