Information available in SafeSeaNet



➤ Ship notifications:

- AIS and
- MRS

➤ Port Plus notifications:

- Pre-arrival (72h - 24 hours), arrival and departure
- Hazmat information (dangerous and polluting goods on board)
From June 2015 (Dir. 2010/65/EU)
- Notification of waste and cargo residues (Article 6 of Directive 2000/59/EC)
- Notification of security information (Article 6 of Regulation (EC) No 725/2004)
From December 2018
- Indication whether bunkers details are available
From December 2021 (Dir. 98/41/EC)
- Persons sailing on board passenger ships for SAR purposes

➤ Incident reports:

- Information submitted by MSs about accidents and incidents occurring at sea (e.g SITREP, POLREP etc...)

Voyage vs. Port Call concept in SSN



Voyage

Port A

Port B



- Data comes from 2 ports (departure and arrival)
- Correlation in place (voyage normally created by departure port and updated by arrival port)
- Hazmat, Bunkers and Crew and Pax on departure from Port A is linked to arrival at Port B

Port Call



- Data reported by one port only
- No correlation in place. All information available is from the same provider
- To see Hazmat, Bunkers and Crew and Pax at arrival for ships coming from EU port the previous Port Call has to be consulted



SSN textual interface offers the following possibilities:

- **Search based on ship:**
 - Integrated Ship Information (Voyages, IR, MRS, Exemptions)
 - Next Port, List of next calls and Current and past port calls
 - Ship Port Calls
 - Latest MRS
 - Incident Reports
- **Search based on port:**
 - Ships expected at a port
 - Ships in port
 - Ships departed from a port
- **Search based on ShipCallID or based on IncidentID**
