ARTICLE III.1 - SUBJECT MATTER

- III.1.1** This specific contract implements Framework Contract (FWC) No *[complete]* signed by EMSA and the contractor on *[complete date]*.

ARTICLE III.2 - ENTRY INTO FORCE AND DURATION

- III.2.1** This specific contract shall enter into force on the date on which it is signed by the last party.
