The Harmonized Training Program (HTP) presents in detail the sequence of activities for the delivery of learning services outside formal education within a calendar year. The learning services included in the HTP are identified through a structured Training Need Analysis (TNA), performed by EMSA and are approved by the Administrative Board on an annual basis.

**Online asynchronous learning** refers to interactions where facilitators and learners are not online at the same time, so the learning process is self-paced by students.

**Online synchronous learning** relates to interactions where facilitators and learners must share the same online spaces at the same time for learning to take place.
