**DECISION OF THE ADMINISTRATIVE BOARD to give a delegation to the Executive Director to act as Reporting Officer in the context of appraisal for the Accounting Officer**

THE ADMINISTRATIVE BOARD OF THE EUROPEAN MARITIME SAFETY AGENCY,

Having regard to Council Regulation (EC) N° 1406/2002 of 27 June 2002, as amended, establishing the European Maritime Safety Agency, and in particular Article 6 thereof;

Having regard to the Staff Regulations of Officials (Staff Regulations) and Conditions of Employment of Other Servants of the European Union (CEOS), laid down by Council Regulation (EEC, EURATOM, ECSC) N° 259/68, as last amended<sup>1</sup>, and in particular Articles 43 and 44 of the Staff Regulations and Article 15(2) and Article 20(4) of the CEOS;

Having regard to the decisions of the Administrative Board of 25 March 2015 laying down general provisions for implementing Article 43 of the Staff Regulations and implementing the first paragraph of Article 44 of the Staff Regulations for officials and temporary staff;

Whereas the Appointing Authority for the Accounting Officer is the Administrative Board;

Whereas under the previous appraisal procedure, the Administrative Board has given a delegation to the Executive Director to act as Reporting Officer for the Accounting Officer, with the involvement of the Administrative Board as countersigning officer (Chairperson of the Administrative and Finance Committee);

Whereas the Administrative Board is now directly involved under the decision of 25 March 2015<sup>2</sup> in the case of appeal or of a report concluding that the performance of the Accounting Officer has been unsatisfactory for 2(f) temporary agent staff where the reporting officer is the Executive Director;

Whereas in the light of the new rules, a new delegation from the Administrative Board to the Executive Director to act as Reporting Officer for the Accounting Officer is required;

HAS DECIDED AS FOLLOWS:

**Article 1**

The Administrative Board hereby gives a delegation to the Executive Director to act as Reporting Officer for the Accounting Officer.

**Article 2**

This decision shall take effect on the day following that of its adoption.
